### **Dust Control permit General Requirements**

1. No cultivation of soil during periods of high winds.
2. During the months of \_\_\_\_\_, an adequate supply or source of water and/or sprinkler lines shall be maintained and readily available to cover all areas of a field where any soil disturbance has occurred.
3. Sufficient residue/stubble will be left on all properties where grazing is allowed to occur.
4. During any windy periods sufficient to cause soil movement, any activity, which may disturb the soil shall be subject to immediate termination based upon forecast of actual wind velocities and shall have water applied in adequate amounts to prohibit the movement of soil.
5. A person of authority shall be available at all times to immediately carry out any stipulations by the Agricultural Commissioner's Office to terminate soil disturbance activities and apply adequate water when a windy condition will cause soil movement off-site.
6. Noble blading and discing in vineyards will commence only when substantial weed growth is apparent.
7. All plant material remaining from cultivation will not be removed to help maintain soil stability.
8. Cultivation machinery shall not operate in windy conditions.
9. All soil cultivation practices should occur at tight angles to the prevailing wind patterns.
10. The water source must be readily available at any request from this office.
11. Sprinkler irrigation will always be available during the months of Oct-March.
12. Cultivation practices will be done in such a manner as to minimize soil instability.
13. A cover crop or stubble shall remain from Oct-march to protect against soil movement, if field not planted.
14. All permit applicants are advised to contact the local Resource Conservation District office for further assistance on minimizing fugitive dust.
15. The dust control permit is conditioned upon all stated requirements. Failure to comply with any requirement may result in the revocation of permit and other actions as allowed by the Ordinance.
