STRUCTURAL PEST CONTROL OPERATORS: Please complete and sign the enclosed form, including the "BRANCH OFFICES" section and the license number sections and send with the fee of **\$25.00** (make check payable to the *County of Riverside*). Please write the "**branch license number**" for each branch office in the space provided. An incomplete registration form may result in delaying the registration process. If you have applied for an operator's license and have not received it, please contact the Structural Pest Control Board prior to registering in Riverside County. **No registrations will be processed without a valid license.** We are no longer accepting monthly summary use reports with both Agricultural and Structural on one form. Please submit separate forms for both, and include the original plus one copy for each type of report. Negative use reports do not require a structural stamp. **NOTE: A 24-hour Notice of Intent to apply MBr, Vikane, Zythor, Master Fume, Makr, or Blizzard is required.** This notice of intent should be reported by fax at (951) 955-3047, or in person. Please provide the following information.

- 1) Date and Time NOI is sent
- 2) Company Name
- 3) Phone Number
- 4) Application Address and City
- 5) Description of site to be treated
- 6) Date of Application
- 7) Map Page and Grid Coordinates (i.e., 7 B2)
- 8) MBr, Vikane, Zythor, Master Fume, Makr, or Blizzard
