To All Beekeepers,

The purpose of this letter is to remind you that it is time again to register all bee hives kept for any part of the year in Riverside County, as provided for in the Food and Agricultural Code.

The annual registration allows this office to more promptly identify the location of bee hives within the county. This is especially important when we must respond to requests from CDFA for special pest surveys, such as for the Red Imported Fire Ant or the Small Hive Beetle. This information is also valuable for compilation of the department's annual crop report.

In addition, the registration process allows our staff to advise beekeepers of the county ordinance related to the keeping of bees. With the ever increasing urbanization of the county, conflicts between landowners and bees can be more effectively managed if we know whom to contact regarding a specific colony of bees.

Lastly, the annual registration process allows our office to provide beekeepers with any relevant pesticide notification information, as provided for in the Food and Agricultural Code and the California Code of Regulations. This notification process was developed to help protect bees from being sprayed by pest control operators in the normal course of treating for pests in the various agricultural crop situations throughout the county.

Please complete the attached registration form, along with the pesticide notification, if desired. Also, please include a detailed map for each bee location. This list should be updated throughout the year when bees are moved in and out of the county.

Included with this letter are several important attachments. The first attachment is the apiary registration form, including the section for pesticide notification. A copy of the pertinent sections of the California Code of Regulations (CCR) is provided for reference. Also included is a copy of the Riverside County Ordinance relating to the keeping of bees (Ord. No. 551). Lastly, a request for crop statistics for the 2011 season is attached. If you have not already returned this form, please complete and return to our office as soon as possible.
